Dynamic Model

Starting in 2017 we are accepting both pan-Arctic and pan-Antarctic sea ice extent (either one or both) of the September monthly mean. As in 2016, we are also collecting Alaskan regional sea ice extent. To be consistent with the validating sea ice extent index from NSIDC, if possible, please first compute the average sea ice concentration for the month and then compute the extent as the sum of cell areas > 15%.

Alaskan regional sea ice extent is 0.1607 million square kilometer. Alaskan region total area is 4.012 million square kilometers.

We used the Regional Arctic System Model (RASM), which is a limited-area, fully coupled climate model consisting of the Weather Research and Forecasting (WRF) model, Los Alamos National Laboratory (LANL) Parallel Ocean Program (POP) and Sea Ice Model (CICE) and the Variable Infiltration Capacity (VIC) land hydrology model (Maslowski et al. 2012; Roberts et al. 2014; DuVivier et al. 2015; Hamman et al. 2016; Hamman et al. 2017; Cassano et al. 2017). WRF and VIC are configured on the same polar stereographic grid at 50-km resolution, and POP and CICE are sharing a rotated spherical grid at 1/120 (~9 km).

Before June 2017, reanalysis data is used to force the model from September 1979 through May 2017. Starting in June 1, 2017 NCEP version 2 Coupled Forecast System model (CFSv2) seasonal forecasts are used

Brief explanation of Outlook method (using 300 words or less).

Twelve seasonal forecast ensemble members were used to determine a pan-Arctic and Alaskan regional ensemble mean September 2017 ice extent. Those were based on three different RASM initial states (or root cases, produced by three different 09/79-05/17 simulations. Each root case was run forward with four different versions of CFSv2 boundary forcing data starting from 06-01-2017 each root case is split to create four ensemble members forced with CFSv2 data initialized on May 30 at hour: 0000, 0600, 1200 and 1800.
