**Starting in 2017 we are accepting both pan-Arctic and pan-Antarctic sea ice extent (either one or both) of the September monthly mean. As in 2016, we are also collecting Alaskan regional sea ice extent. To be consistent with the validating sea ice extent index from NSIDC, if possible, please first compute the average sea ice concentration for the month and then compute the extent as the sum of cell areas > 15%.**

**"Executive summary" of your Outlook contribution (using 300 words or less) describe how and why your contribution was formulated. To the extent possible, use non-technical language.**

A linear Markov model is used to predict monthly Arctic sea ice concentration (SIC) at all grid points in the pan-Arctic region (Yuan et al., 2016). The model has been retrained this month using SIC, atmosphere variables and SST from 1979 to 2021. It is capable of capturing the co-variability in the ocean-sea ice-atmosphere system. The September pan-Arctic sea ice extent (SIE) is calculated from predicted SIC. The model predicts negative SIC anomalies throughout the pan-Arctic region. The September mean pan-Arctic SIE is predicted to be 4.68 million square kilometers (mskm) with an RMSE of 0.41 mskm based on model cross-validation experiments, at the two-month lead. The Alaskan regional SIE is predicted to be 0.46 mskm. A Similar statistical model was also developed to predict the SIE in the Antarctic (Chen and Yuan, 2004). The September mean pan Antarctic SIE is predicted to be 18.28 mskm, with an RMSE of 0.60 mskm. The RMSE is estimated based on our model forward forecasts from 2003-2022.

**Brief explanation of Outlook method (using 300 words or less).**

The linear Markov model has been developed to predict sea ice concentrations in the pan Arctic region at the seasonal time scale. The model employs 6 variables: NASA Team sea ice concentration, sea surface temperature (ERSST), surface air temperature, GH300, vector winds at GH300 (NCEP/NCAR reanalysis) for the period of 1979 to 2021. It is built in multi-variate EOF space. The model utilizes first 11 mEOF modes and uses a Markov process to predict these principal components forward one month at a time. The pan Arctic sea ice extent forecast is calculated by summarizing all cell areas where predicted sea ice concentration exceeds 15%.

**b) Brief explanation/assessment of basis for the uncertainty estimate (1-2 sentences).**

The uncertainty of SIC prediction was measured by root-mean-square error (RMSE). They were estimated based on 42 (1980-2021) years (take-one-year-out) cross-validated model experiments.

**c) Brief description of any post-processing you have done (1-2 sentences).**

First, a constant bias correction was applied to Arctic SIC prediction at each grid point. These biases were estimated based on the take-one-year-out cross-validated predictions for 1980-2021. Then a constant SIE bias also derived from the cross-validation experiments from 1980 to 2021 was corrected from the September SIE prediction. Finally, the model uses lower resolution sea ice concentration data (2-degree longitude x 0.5-degree latitude), introducing a 0.10 million square kilometers bias compared to 25kmx25km original satellite data. This resolution bias is corrected in the final Arctic SIE prediction.
